On October 3, 2009 the Working Group on Native American Human Remains will hold an open session in Cambridge, MD, to solicit comments on proposed statements of principle regarding the disposition of those remains currently in the care of the State. The proposed statements of principle are the result of nearly a year's work by the Working Group, and represent a general proposal agreed to by all members of the Group. The Working Group is comprised of ten individuals, five designated by the Maryland Commission on Indian Affairs, and five designated by the Maryland Historical Trust. The Working Group was established by the Secretary of Planning to consider options for an Appropriate Place of Repose for certain Native American Human Remains currently in the care of the Maryland Historical Trust.
