BALTIMORE COUNTY Sila Residence, BA-3360

Criteria Considered: A & C Criteria Recommended: A & C

The discussion included recommendations by members of the Committee for additional information about the Turkish design of the residence and for general clarification of language within the nomination. Don Linebaugh moved to approve the nomination with the recommended adjustments, Damie Stillman seconded, and all others voted in favor.

CECIL COUNTY

West Nottingham Presbyterian Church, CE-227

Criteria Considered: C Criteria Recommended: C

The Committee's discussion included recommendations that a map with a larger scale be included, that the connection of the church with West Nottingham Academy be emphasized more, and that a better description of the original church be provided. Richard Longstreth moved to approve the nomination with the recommended adjustments, Nancy Schamu seconded, and all others voted in favor.

CHARLES COUNTY

Bel Alton High School, CH-562

Criteria Considered: A & C Criteria Recommended: A & C

The discussion included a recommendation to include a map with a larger scale and to remove references made to "Beaux Arts Revival." Damie Stillman moved to approve the nomination with the recommended adjustments, Don Linebaugh seconded, and all others voted in favor.

MONTGOMERY COUNTY

River Road Unitarian Church, M:35-214

Criteria Considered: C Criteria Recommended: C

The Committee's discussion included whether to hold the nomination to place more emphasis on Keyes, Lethbridge and Condon's design, which ended with a determination that the nomination could move forward as written. It was recommended that the nomination include a more detailed integrity statement. Peter Pearre moved to approve the nomination with the recommended adjustments, Damie Stillman seconded, and all others voted in favor.

PRINCE GEORGE'S COUNTY

Bladensburg Battlefield, PG:68-134

Criteria Considered: A & B Criteria Recommended: A & B

The discussion included whether Section 7 should be re-focused, which ended with a determination that the nomination could move forward as written. Another recommendation was to add maps that are clearer and to reference the maps within the narrative. Don Linebaugh moved to approve the nomination with the recommended adjustments, Peter Pearre seconded, Nancy Schamu abstained, and all others voted in favor.
