DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE	
<p>The house and service building stand on the northerly side of Scenic U.S. Route 40 about .1 mile west of the intersection of Orleans South Road in eastern Allegany County, Maryland.</p> <p>The house is a two and a half story, frame structure with a gable roof and a one story porch that runs across the principal facade (south side) and along the west side. The structure consists of a rectangular block with an east/west roof line and an ell wing with a north/south roof line attached to the westerly side of the back (north side). The principal facade has four bays, two doorways flanked by two windows, on the first floor and three evenly spaced windows on the second floor. A cement block external chimney rises on the west side piercing the roof at the peak of the gable. A brick chimney stands at the back of the ell wing. The exterior walls are covered with clapboards and the roofs with tin sheeting. The porch has eleven turned posts. The area beneath the porch is covered with narrow stripes vertically spaced a few inches apart.</p> <p>The service building, probably an ice or spring house, is a low structure of stone constructure with a large gable roof. It is built into a bank. The building is entered by a door in the front (southerly side). The roof is covered with tin sheeting. The gables have verticle board siding.</p> <p>Both structures appear to be in sound condition with only minor changes, such as the new chimney.</p>

STATEMENT OF SIGNIFICANCE			
<p>This house is representative of a type of dwelling that Henry Glassie calls the "most usual" farmhouse in the Mid-Atlantic region.¹ (<u>Pattern in the Material Folk Culture of the Eastern United States</u>, pp. 54-55.) The building has an approximately symmetrical facade and the typical double front doors. Long after it had ceased to be fashionable, the English Georgian mode house with a symmetrical facade and floor plan continued to be built throughout the nineteenth century and well into the twentieth. This house, built probably in the late 1800s, is an example of a variation commonly found in southern Pennsylvania but not found that much in Allegany and Garrett Counties where the three and five bay facade seems to be the more usual.</p>


