This one-story frame bungalow appears to date from the second quarter of the twentieth century. The gable roofed dwelling faces south. This side features a shed roofed dormer and a semi-exposed cellar. A porch covers the central entrance. 1/1 sash windows light the three bay by two bay structure. A small frame addition is located at the north end of the west side.

This building is not an exceptional example of its type. Therefore it is recommended as not eligible for the National Register of Historic Places.
