This two story frame dwelling faces Old Rt. 40 to the south. The three bay by two bay structure has a two bay addition at the rear. An enclosure at the east end of the front porch forms the main entrance. The west side of the ell is covered by an enclosed porch. An exterior concrete block chimney is located at the west end of the main house. Asphalt shingles cover the roof and German siding sheathes the walls. 2/2 sash windows are framed with flat boards which are molded across the top.

A one story three bay structure which appears to be a summer kitchen stands northwest of the house. This building is covered with board and batten siding. A gabled picnic pavilion is located southwest of the house. Several small frame sheds run along the northern boundary of the property.

This house has been altered by additions and is not a distinctive example of its type. It is recommended as not eligible for the National Register of Historic Places.
