DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Yonkers Rock Pile group was not seen by the DNR survey team as the team was not aware of its existence at the time of the visit to Green Ridge State Forest. The site, was, however, visited by Mr. Tyler Bastian, State Archeologist in September, of 1975. According to Mr. Bastian the rock piles are located in a timbered area on the west side of Fifteenmile Creek southeast of Long Pond. The archeologist found a group of about a dozen small piles about three feet in diameter by six inches to one foot high. These piles are arranged around a rectangular depression with straight interior sides. Also found were fragments of a cast iron stove and a stone retaining wall. This site is explained in part as a settler's homestead. However, a purpose for the small rock piles was not suggested.

STATEMENT OF SIGNIFICANCE

From descriptions of this site given by the state archeologist it would seem that it was a mountain homestead. Evidence indicates that the mountains of western Maryland were dotted with home sites in the 19th century. A number of these sites have been abandoned and have fallen into disuse or have returned to nature. Although the site carries no known architectural or historical significance, its location should be noted and any data on its history that comes to light should be kept by DNR.


