DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

HARTSOCK HOUSE. A brick "L" farmhouse of the early-middle nineteenth century typical of the local farmhouse for that period. The south elevation is the entrance facade, four bays wide and two stories high. The western gable end is blank, the ell extends north from the eastern gable wall. The roof is a low gable, ridge parallel to the facade. The house is on a high basement, owing to the slope of the ground higher in front than in back. There is a one story, hipped roof porch along the entrance facade.
