DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

HOWARD ROBINETTE HOUSE: Dating from the mid-nineteenth century, this house is representative of the best of the local vernacular. Two stories high, and three bays long on the elevation (very widely spaced along the unusually long facade) with a shed porch along the first story facade, with 6/6 windows, the house is notable for its detail. Jigsaw balusters and brackets appear on the porch, cut out ventilators in the gable ends, simple window frames and eave mouldings, painted in a grey-blue which contrasts with the white painted clapboard siding. There are two entrances on the facade. The house sits on the south side of the old National Pike, across from an old barn, gas pumps and a small cemetery.
