The building stands on the south side of Main Street in Oldtown, Allegany County.

The building, a former church, is a two and a half story frame structure with a steep roof, large double-hung wooden sash windows with multipane colored glass, and a three story intrane tower along the west side.

It is structurally sound and appears to be fairly original on the exterior although in need of some repair.

Basically rather modest in execution, the structure has the high pitch roof and large windows that are characteristic features of the style.</p>


