This property was sold to Samuel T. Stallings, a prosperous farmer of the Spring Gap area, in 1866, and the Stallings family owned it for eighty-five years, until 1941. The name Stallings is familiar in Allegany County, and has been identified prominently in the affairs of the County for many years, politically and as farmers and merchants. Stallings Log House is a typical rural log dwelling; wall construction is of logs with mud chinking covered with vertical planks and insulbrick siding.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Stallings Log House is located on the eastern side of Frog Hollow Road near Spring Gap, Maryland.

This building consists of a two and one-half story, three bays wide rectangular structure. Wall construction is of logs with mud chinking covered with vertical planks and insul brick siding.

The building rests on wooden posts with a row of stones wedged under the sill with no apparent water table. The gable flank roof is covered with asphalt shingles. Eaves consist of a simple overhanging cornice with fascia on the flanks and close pent eaves on the gabled ends.

An original corbeled brick chimney is located inside end. The main entrance (with no door) and the windows are pedimented. The three over one light windows are replaced.

A shed roofed porch on the southeastern facade rests on wooden posts, the porch roof is supported by rough hewn wooden posts.

STATEMENT OF SIGNIFICANCE

The Stallings Log House stands on two tracts of land known as "White Oak Grove" and "Tracey's Resurvey."⁽¹⁾ The property was sold to Samuel T. Stallings in 1866, and the Stallings family owned it for eighty-five years, until 1941.⁽²⁾ "The name Stallings is familiar in Allegany County, and has been identified prominently in the affairs of the County for many years, politically and as farmers and merchants."⁽³⁾ This family of Stallings worked as farmers in the Spring Gap region of the County.

The Stallings Log House, although in deteriorated condition, is a typical rural log dwelling and stands as a reminder of the way of life experienced by a farming family in the nineteenth century in eastern Allegany County.
