ca. 1860

Furlow Log House stands on land surveyed by John Hoyer in 1841. The executor of Hoyer's will sold a 308 acre tract to Samuel D. Furlow in 1860, and most likely this log house was built on it shortly thereafter. The house originally consisted of a one and a half story, three bays wide log structure with "V" notching, a common construction technique used by many rural Allegany County residents. Logs were a functional building material in this area of abundant forests. The house is a reminder of a common type of rural dwelling and of 19th century farmers in eastern Allegany County.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Furlow Log House is located north of Maryland Route 51 near Spring Gap.

This house originally consisted of a one and one half story, three bays wide log structure with "V" notching. It rests on a low foundation of random rubble with no apparent water table. The gable flank roof is covered with tar paper. Eaves consist of cornice and soffit. One centrally located replaced chimney is made of brick. There is evidence that a stone chimney stood outside end on the northeast.

The main entrance is in the center of the northwestern facade with a replaced door. Windows are mostly pegged six over six lights. A replaced shed roofed porch is on the northwest. A one bay wide, gabled, board and batten addition on the southwest rests on stones at the corners.

STATEMENT OF SIGNIFICANCE

This acreage was surveyed by John Hoyer, who received a patent for the land on March 30, 1841.⁽¹⁾ Hoyer had bound himself to convey land to Samuel D. Furlow November 14, 1846, but died before this conveyance was completed.⁽²⁾ However, in 1860, Furlow did get the 308 acre tract from the executor of Hoyer's will.⁽³⁾ Most likely this house was built shortly thereafter. Furlow defaulted on a mortgage, and an equity case resulted. The order nisi from Equity 4086 mentions 75 acres of cleared land and two good dwelling houses.⁽⁴⁾

This house is constructed of "V" notched logs, a common construction practice used by many rural Allegany County residents. Logs were a functional building material in an area of abundant forests.

Furlow Log House is a tribute to and a reminder of a common county-wide building practice and of a way of life experienced by 19th century farmers.


