DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

LILIER, GEIGER: A house of unusual size and pretention for the area, frame, large, two story, with a relatively complex roof of intersecting gables. The entrance facade is of five bays, with a single slope of gable above (i.e., ridge parallel to the facade). There is a small entrance porch with hipped roof. Numerous fine details are painted blue in contrast to the white clapboard siding: Greek revival window frames, attic ventilator panels, gable-end barge boards and eave mouldings. Windows are 2/2, taller on the first story than on the second. Stylistically, the house dates from the 1870's.

Two stories, five bays, frame house with cornerboards, gable flank asphalt shingle roof, replaced entrance in center of front facade, pedimented 2/2 light windows, hipped roof portico.
