DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

MILLER BROTHERS GARAGE: An early twentieth century service station complex consisting of two buildings on the south side of U. S. 40. The garage is a long frame gable roof building of a single story with a parapet facade. The gas pump shelter is a shed roof parallel to the garage, supported at the north end by frame supports which taper toward the ground on the inside opening, and on the south by a frame building housing an office/store. The pump and office structure is painted white with red accents. The whole is a highly unusual example of an early approach to the service of motor traffic, and is certainly unique in the area if not the entire state.

Large gable roof extends far beyond building to cover service area, gas pumps, supported by wooden posts (Like a wagon shed). Frame with double windows, shed roof addition, interior chimney.
