 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This simple two-story frame house is three bays wide by one bay deep and faces east. It is clad in novelty siding with narrow vertical corner boards. A shed-roofed porch, supported on square columns, shelters the central entrance, which has a single-pane transom and is flanked by 1/1 sash windows. Three 1/1 sash windows appear on the second story, aligned over the first-floor openings. An interior end chimney rises from the peak of the east gable. Roof covering is asphalt shingle.


