This two-story frame house measures four bays long with a small enclosed porch at the rear. A one-story porch covers the east-facing main facade. Two doors occupy the center bays. A small chimney rises from the middle of the metal-clad roof. Aluminum siding sheathes the walls and modern aluminum 1/1-sash windows light the house. A small frame gabled outbuilding resting on a concrete-covered semi-exposed cellar is located north of the house. A small frame bank barn stands to the northwest.

Modern materials have so altered the design, materials, workmanship, and feeling of this building that it is recommended as not eligible for the National Register of Historic Places.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This 2 1/2 story frame duplex is four bays wide by two bays deep and faces east. Fenestration of the east facade is symmetrical, with entrances occupying the two central bays and 1/1 sash windows in the outlying bays; four 1/1 windows on the second story are aligned over the first-floor openings. A shed-roofed porch with modern iron railing and supports spans the facade. A small central chimney rises from the ridge of the gable roof. The building is clad in novelty siding. A sizable frame barn lies to the northwest.


