

AL-III-110 Hillcrest Memorial Park

This cemetery is located in the Wolfe's Mill area east of Cumberland. It occupies the slope of a southeast-facing hill that rises steeply to a promontory. The graves date from about the turn of the century, c. 1900. As there are no exceptional characteristics to this cemetery it is recommended as not eligible for the National Register of Historic Places. AL-III-C-048 Hillcrest Memorial Park Funeral Chapel has been reviewed separately and found to be eligible.
