This two story frame farmhouse has a three bay main section facing south and a rear ell. An enclosed porch covers the front of the house and a modern deck adjoins the east side. Asphalt shingles cover both gable roofs and German siding sheathes the house. The building's 2/2 sash windows are framed in flat board architraves. A board and batten gable-roofed horse barn is located south of the house.

This house appears to date from the late nineteenth century. It has lost integrity of design due to modern additions. It is recommended as not eligible for the National Register of Historic Places.
