DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This small frame church, three bays wide by three bays deep as originally constructed, rests on a low stone foundation facing east. The double five-paneled entrance doors are centered in the east gable facade, surmounted by a large peaked transom of flashed and etched glass and sheltered by a gabled hood with stickwork brackets. Tall, peaked 5/6 sash windows of flashed and etched glass flank the entrance, and identical windows define the three bays of the north facade. A belfry with a turned finial, bellcast roof, dentilled cornice, and openings whose shape repeats that of the windows, rises from the peak of the east gable. A small turned pendant with scrollwork brackets decorates the peak of the eaves. The building is clad in novelty siding, with standing seam metal covering the roof. A large, recently-constructed wing extends to the south.

A marble cornerstone at the northeast corner of the foundation reads: "In memory of Harvey Johnson. Son of George & Rebecca Elliott. Born August 30, 1865. Died March 27, 1890."


