The Beall Log House is situated one mile from Cumberland north of Mt. Pleasant Road. In 1853, Thomas D. Beall and his wife, Tacy, sold the property to William Beall while reserving the right to the "premises" for themselves as long as they both lived. Evidently, the house was built before 1850, most likely during the time Thomas D. Beall lived there. The Beall Log House does not retain its original appearance since it has been obscured by two additions and covered with clapboards and german siding. However, it is a reminder of the well-known Beall family name, and the way of life experienced by many farming families in northern Allegany County.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This log house stands north of Mount Pleasant Road.

The original two story three bays wide log structure has been obscured by additions on two sides. It is covered with clapboards and german siding. The high random rubble stone foundation is partially sheathed in cement. A corbeled brick chimney was outside end of the original now is encased by an addition. The front door has been replaced but an old vertical board basement door remains intact. One over one light nailed windows are pedimented. A one light recessed casement in the gable is original. Windows on the southwestern facade have shutters.

The older addition is on the northeast. This small gabled addition is frame with clapboards, resting on stone pillars at the corners. A later addition abutts the southeast of the original. This gabled addition is frame with german siding, resting on wooden posts. An entrance on the southwest of this addition has a one light transom.

The replaced gable flank roof over the original and the later addition is covered with asphalt shingles. Eaves consist of a simple overhanging cornice with a bedmould.

A hip roofed porch on the southwest has seven decoratively cut posts, two engaged. A shed roofed porch on the earlier addition has square wooden posts.

STATEMENT OF SIGNIFICANCE

The Beall Log House is situated just one mile from Cumberland off Mt. Pleasant Road. The house stands on property described as "all those parts of tracts of land called 'Briscoe's Farm,' 'Dart's Neglect,' 'Lion's Den,' 'Fox Chase,' and 'Timberland,' lying west of division line... laid off between William Beall and Asa Beall."⁽¹⁾ In 1853, Thomas D. Beall and his wife Tacy sold the property to William Beall. The deed mentions that Thomas and Tacy Beall reserved the right to use the "premises" as their own as long as they lived.⁽²⁾ Interpreting "premises" to mean the log house on the property, it is evident from this information that the house was built before 1850, most likely during the time Thomas D. Beall lived there.

The Beall Log House does not have its original appearance since it has been obscured by two additions and covered with clapboards and german siding. Yet, it stands as a reminder of the way of life experienced by farming families in northern Allegany County, particularly a family with the Beall name, which is well-known in this county.




