DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Pleasant Valley School is located on the east side of Pleasant Valley Road just north of U.S. 40 at Rocky Gap State Park between Flintstone and Cumberland in Allegany County, Maryland. The structure is situated on a level plot of land overgrown with brush and high grass and faces with its gable front toward the road.

The school is a one story, three bay, rectangular frame building sheathed with asbestos shingle siding. Its facade is pedimented and the area within the triangle of the gable is covered with decorative wooden scalloped shingles. Near the peak of the gable is a small round window. A pedimented entrance porch extends from the facade above the front door.

Openings are arranged symmetrically in the walls. Architraves have flat tops with molded trim. Windows are large in relation to wall area with six over six pane sashes at the front elevation and four over four light windows at the side walls. Most of the glass is gone from the sashes. The door is centrally placed in the front elevation and includes a tall transom with its glass also removed.

At the front elevation the barge and pent area have simple trims. Elsewhere, plain boxing finishes the eaves. The roof is covered with sheet metal. Two modern block flues are present.

The interior of the house was divided into partitions indicating that it was used as a dwelling.

The building is in poor condition and has been scheduled for demolition by DNR.

STATEMENT OF SIGNIFICANCE

The Pleasant Valley School House is an example of typical turn of the century period country school building form and illustrates in part the history of rural education in central Allegany County. Prior to its ownership by DNR, it was part of a larger farm complex containing nearly 400 acres, known as Clover Hill Farm. Possibly during this time the school was converted to a dwelling. It was acquired by DNR in 1963.

The demolition of this building by DNR was approved by the Maryland Historical Trust.


