DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This barn is a wood frame structure with a concrete block foundation situated at the edge of the lake at Rocky Gap State Park. It is a two story gambrel roofed building which would appear to date from the 1940s or 1950s. Attached to the end of the barn nearest the lake is a leanto wagon shed also with a block foundation. The structure has a sheet metal roof at the rear of the barn which stands against a slope are two large concrete ribbed silos.

The barn is in deteriorated to fair condition with damage to its foundations from moisture seepage from the adjacent lake. Sections of sheet metal roofing are also loose.

Demolition is planned for the building.


