DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This structure is a 20th century framehunters' cabin, resting on concrete block foundations. It is a one story, three bay structure, sheathed with random boards over which asbestos shingle siding has been applied on three sides. The building has a central block chimney and an asphalt roof. It is in deteriorated condition and is slated for demolition by DNR. Other structures which were once part of the complex have already been removed. These included a privy and two frame sheds.


