<p>101 South Centre Street in Cumberland, Allegany County, stands on the western side of the street in the block formed by Dexter Place and Harrison Street, across from the intersection of Union and Centre Streets.</p> <p>The building is an early twentieth century (possibly late nineteenth) eclectic revival brick structure, two stories in height with a low gable roof covered, at least on the street side, with curved tile. The building stands tight to its neighbor on the south side but free of, and closer to the street than the structure to the north. The northwest corner of the building is rounded and has a rectangular metal panel with a torch and floral design. A small marquee hangs over the double-door entrance.</p> <p>The building is structurally sound and the exterior is basically unaltered since construction.</p>


