STATEMENT OF SIGNIFICANCE

48-52 Baltimore Street is representative of late nineteenth century Romanesque influenced commercial architecture as found in Cumberland. A photograph of the building published in the 1897 Art Work of Allegany County (part 5) identifies the structure as the Walsh Building. It has become known in recent years as the Clark-Keating Building.


