DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>The building stands on the southeast corner of Baltimore Street and South Mechanic Street in Cumberland, Allegany County.</p> <p>The building is basically a two and a half story brick structure with modern shop fronts along Baltimore Street. The upper levels and the west side were completely covered in recent years and have few windows, none on the Baltimore Street side. The east and south sides are tight to the neighboring structures.</p> <p>A photograph of downtown Cumberland that was published in <u>Art Work of Allegany County</u> (1897) shows that the structure had shop fronts on the first floor and six windows along Baltimore Street and four plus along Mechanic Street on the second floor in the late nineteenth century.</p>

STATEMENT OF SIGNIFICANCE			
<p>Although greatly altered, this building is a remnant of pre Civil War commercial architecture in downtown Cumberland. It is presently owned by the Urban Renewal Agency and may be scheduled for demolition in the near future.</p> <p>The photograph referred to in the description indicates that the building is of the type that was generally being built in the area in the 1830s and 1840s.</p>


