<p>Washington's Headquarters stands in Riverside Park, on the west side of Wills Creek, at the intersection of Greene Street and Route 28 in Cumberland, Allegany County.</p> <p>The building is a one story, one room log house with a gable roof and a small front (west side) porch. The logs are laid with V notching, square corners, and large spaces between the logs. At the present, the logs are dark color and the chinking is white. A large external stone chimney rises in the north side. The principal facade has a door, not original, and a window. This window and the one on the south side have a single shutter each and double-hung wooden sashes with six-over-six lights.</p> <p>The building is structurally sound but was rebuilt at least once. The window shutters have circular saw marks that prove they were added later.</p>

STATEMENT OF SIGNIFICANCE

The one room log house that stands in Riverside Park is traditionally said to be the building that George Washington used as his headquarters while at Fort Cumberland in the mid-late 1700s.

Tradition says that the building was purchased in 1844 by Judge Perry, who moved it from its original site on Washington Street to the farm of a friend. James W. Thomas, a local historian, acquired the house and donated it to the city in 1921. Since that time, the building has been a symbol of Cumberland's respect for the General who later became the first President of the United States.




