## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building with Greek Revival features, is located at 112 Washington Street, Cumberland, Maryland.

The building basically consists of a two story, three bay wide, "T" shaped structure with one wing and one addition. Wall construction is brick, laid in American common bond using mostly random variations except for the north (front) facade using mostly stretcher bond. A wall plaque mounted on northwest corner of the front facade reads "Built 1853." Windows feature the use of pegs in their construction. The building is supported by a high, stone foundation of rough-faced, coursed ashlar bond. (Sheathed in cement on wing and eastern facade). Foundation features stone capping with a beveled water table. The roof is gable front and covered with rectangular asphalt shingles. Eaves of the roof feature a boxed cornice with wide soffit and frieze. Decorative brackets located under the eaves are continuous around the main building. The five brick chimneys are original with corbeled caps located flush end.

Northern facade on first floor has two double hung, six-over-six light windows with wooden labels, lugsills and plain trim. The front entrance located here is recessed with shouldered architrave trim. Door is six paneled (recessed, architrave trim) vertical boards with a three light, plain glass transom. Leading up to the door are cement front steps with floral design wrought iron railing. Second floor features three windows, same as first floor plus wooden louvered shutters located inside.

Eastern facade has two iron grates on the basement level. Windows on this facade are identical to those of northern facade except for wooden lintels instead of labels and that the window on second floor northeast corner, has wooden louvered shutters inside. On the southeast corner are recessed french doors of six lights each side with a three horizontal lights transom, wooden lintel and plain trim.

Western facade has two basement windows with wooden slipsills and plain trim. Each has two lights of eight panes of black glass squares with design. Northernmost window is a casement and swings out. Southernmost window is a hopper and tilts in. First and second floor windows identical to those of eastern facade.

First floor of southern facade has one double hung, six-over-six light window with wooden lintel, lugsill and plain trim. Second floor window identical to first floor. Located in the peak of the gable on this facade is a louvered ventilator with plain trim.

The wing and frame addition are located on southern facade and joined together, both with shed roofs. The wing is brick construction with brick cornice on western facade. Frame addition features novelty siding and has fascia on southern facade, cornice and soffit and on east.

## STATEMENT OF SIGNIFICANCE

One hundred and twelve Washington Street is a good example of a simple Greek Revival home. It is one of a group of Greek Revival houses on the eastern end of Washington Street. This building was built around 1853, the original owner was Alfred Shriver. <sup>1</sup> The property was purchased in 1852 for six hundred and fifty dollars and sold thirteen years later for six times the original price. <sup>2</sup> This would indicate that it was Mr. Shriver who had the building erected.

As is usual with most Greek Revival houses in Cumberland, the entrance of this home is offset and part of a three bay main facade. This gable front house has a gently sloping roof with a noticeable overhang supported by simple but decorative brackets. Windows of the original building are tall and slightly narrow. One feature of this building that seems most unusual for Greek Revival design is a set of rectangular wooden labels above the Northern facade windows.

Although there are additions to the rear of this house, it retains practically all of its original appearance, contributing greatly to the architectural heritage of Cumberland. It is a visual reminder of the cultural awareness among the earlier residents of Cumberland.

A wraparound rear porch, with shed roof extends around both the addition and southern facade of the wing. It is supported by both a retaining wall and two wooden posts with lattice screen between them. The porch features splat-boards railing, chamfered posts and lattice screens.

WINDOWS

Northern Facade -

First Floor - Two double hung, 6/6 light, two sash, wooden lugsills, wooden labels, plain wooden trim.

Second Floor - Three double hung, 6/6 light, two sash, wooden lugsills, wooden labels, plain wooden trim. Wooden louvered shutters inside.

Eastern Facade -

Basement - Two iron grates.

First Floor - One double hung, 6/6 light, two sash, wooden lintel and lugsill. Recessed French doors, six lights each side, plain wooden trim, wooden lintel, transom of three horizontal lights. On addition, one window, 49 blocks of thick glass cubes, one metal louvered ventilator in center.

First and a Half Floor - One double hung, 6/6 light, two sash, wooden lintel and lugsill, plain trim.

Second Floor - Two double hung, 6/6 light, two sash, wooden lintels and lugsills, plain trim. (Northeast one has wooden louvered shutters inside). On addition, one double hung, 1/1 light, two sash, architrave trim, shutter hinges.

Western Facade -

Basement - Two with wooden slipsills, plain wooden trim. Each has two lights of eight panes of black glass squares with design. Northernmost is casement, swings out, southern is hopper, tilts in. Two double hung, 3/3 light, two sash, wooden lintels and slipsills, plain trim. One iron grate.

First Floor - Two double hung, 6/6 light, two sash, wooden lintels and lugsills. On wing, one casement, swings out, two lights of three panes each, brick slipsill. On wing, two windows bricked shut with only wooden lintels remaining. Metal louvered ventilator now located in one.

First and a Half Floor - On wing, two casement, two lights each, swing in, wooden lintels and lugsills, plain trim.

Second Floor - Two double hung, 6/6 light, two sash, wooden lintels and lugsills, plain trim.

Southern Facade -

Basement - One wing, one recessed, vertical board door.

First Floor - On wing, one entrance, three paneled, horizontal boards, six lights, wooden lintel. One double hung,

6/6 light, two sash, wooden lintel and lugsill, plain trim (on original building).  
Second Floor - One double hung, 6/6 light, two sash, wooden lugsill and lintel, plain trim. One louvered ventilator in peak of gable, plain trim. On wing, one recessed, two light casement, swings in, plain trim. On addition - one double hung, 6/6 light, two sash, wooden architrave trim with flashing.

<p>112 Washington Street stands on the south side of the street at the intersection of Smallwood Street, southeast corner, within the boundaries of the Washington Street Historic District in Cumberland, Maryland.</p> <p>The house is a mid nineteenth century brick structure of two and a half stories with a low bracketed roof, a dressed stone foundation on the front, and a facade of three bays with the entranceway in the west outer bay. The gable end faces Washington Street and along with the arrangement of the facade (north side) bays, and the wide surround at the entrance give a strong Greek Revival feel. The front windows, all with double-hung wooden sashes and six-over-six lights, have Gothic influenced hood moldings. The low roof has a broad overhang and narrow brackets roughly in the manner of the Italiniate style. The front door has six panels with a large transom above. A small stoop with an iron balustrade stands in front of the door. The stone of the foundation in front have chisled margins and pecked surfaces. The bricks are laid in Common bond.</p> <p>The exterior was recently cleaned of the paint on the bricks and a front porch was removed.</p> <p>For additional descriptive material see the Clark paper on file at Maryland Historical Trust in Annapolis, Maryland.</p>

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

112 Washington Street is a small temple form house with its gable end facing the street. Constructed of brick, this 2 storey house (there is a small 1½ storey wing attached to the rear) is set up on a high stone base (that slopes down the Smallwood Street hill). The house is a symmetrical, regular Greek style house in layout -- there are three bays across the front with doorway set at one side. All windows are tall and narrow (6/6), those on the front have Tudor style flat drip moldings, while the four windows on each of the side walls have simple rectangular wood lintels. There are two chimney stacks rising from the roof along the Smallwood Street side, these run just outside the four windows; on the opposite wall, the four windows are set on the outside of the two chimneys. The front door has a three light rectangular transom and decorative iron railing enclosing 2 sides of the front steps. The gently sloping gable roof has a pronounced overhang supported by simple scrollsaw brackets.


Floor plan







Cumberland grew rapidly in the years around the turn of the century. In 1890, the population stood at 12,729. By 1910, it had grown to 21,839, and by 1920, stood at 29,837. Growth stemmed from economic diversity, which in turn produced a rich cultural life. Much of the community's entertainment was not simple spectator entertainment, but involved activities utilizing local resources. The Potomac

River, for example, was a source of entertainment in summers, when boating and swimming were popular.

Variations in weather patterns produced winters during the early years of the century that featured heavy snows and cold weather. Local youths took full advantage when opportunities for adventure were presented by severe weather. Ice skating

on the Potomac River was a regular feature of Cumberland life in first years of the century. When snows came, sledding was popular. Most was done by children using individual sleds. A few multi-person sleds appeared in the city; sleds which were operated by older youngsters, achieved great speeds, and occasionally caused serious injuries.
