DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

207-209 Washington Street is a double house with each half mirroring the other, the doorways being side by side. Very similar (although twice as large) as 201 Washington Street, this double house has the same recessed Greek Revival doorway and similar triple Greek window on the first floor front. The second storey windows are three per house and are 6/6. 207 has a large frame dormer on the roof [later]. There are double end chimneys, the heavy cornice, etc., however, these houses have gone through some modification (as well as decay), like the dormer and the front steps.

Although almost approaching a deteriorated state, these houses could be as attractive as their nearby Greek Revival neighbors, specifically 201 Washington Street. Good examples [if restored] of urban Greek, these should be considered part of the Washington Street district. [209 has a good wrought iron balcony and stone base.]
