1782--Methodist circuit riders came to Washington County (now Allegany County) Maryland.

Meetings held in Log Church of Lutherans.

1799-Deed--25ft.x 35ft. Corner Fayette & Smallwood Streets. Log church built.

1816-Brick church 36ft.x45ft.replaced log one.

1829-Deed on Mill Street(now North Centre Street) Centre Street Methodist Episcopal Church built.

1837-Church enlarged

1848-Church of 1829 torn down; Replaced by 50ft.x80ft. Church at cost of \$6,000.

1869-Committee from this church named to locate a site for another Methodist Church. They chose Gay Street at Oldtown Road for Kingsley Chapel.

1871-Apr. 30-Memorial service held in old church which was to be torn down the next day. Cornerstone laid in 1871 and the new church was dedicated in 1874.

1912-Addition added.

1928-Another addition called Francis Asbury Hall added. New pipe organ installed.
