STATEMENT OF SIGNIFICANCE

Martin's Plantation was General Edward Braddock's second camp on his march to Fort Duquesne. Braddock and his troops stayed upon this site June 14, and 15, 1755. During this time, his scouts explored the surrounding country side and scouted the trail ahead. The site can only be approximated as there are no records of the exact location and boundaries, only that it was to the Southeast of the National Road.

A sign marks the location of Martin's Plantation and is a reminder of the historic march of General Braddock to Fort Duquesne, which was one of the first military roads in Western Maryland.




