According to the date stone located in the southwest gable, construction on the Logsdon House was completed in 1854. The property on which the house was built was purchased in September of 1850 and construction of the house was probably started shortly thereafter. The house was built by Peter Martin for William Logsdon and took four years to complete. It is one of a very small group of stone structures that are constructed with regular ashlar bond in Allegany County and in addition is one of the largest of its type.

The Logsdon Stone House is located on the southwest side of the Bald Knob Road approximately one mile north of Mt. Savage, Allegany County, near the intersection of Bald Knob Road and Hinkle Road. The house commands a sweeping view to the south-east from the Mt. Savage area to The Narrows leading into Cumberland. The L-plan two story stone farmhouse faces southeast. A stone springhouse is located about 50 yards to the north. A second spring, feeding a pond, appears in a field to the northeast. A timber framed outbuilding on a stone foundation is located to the north. A stone wall runs behind this building. A timber framed bank barn on a stone foundation is located to the west. A log house which predated the present stone house was located to the east.

The two story, five bay house includes an original two story stone kitchen wing extending to the northwest. Both sections are covered with metal clad gable roofs. Interior stone chimneys heat either gable end of the main section and the northwest gable end of the ell.

The masonry consists of large sandstone blocks laid in regular ashlar bond. The gable end of the kitchen consists of well-laid rubble sandstone. Two or three blocks form each lintel.

A semi-circular datestone located above the two southwest attic windows states that the house was built by Peter Martin in 1854. Other lettering, now indecipherable, may note that the house was built for William Logsdon. A diamond shaped stone set in a similar position in the kitchen chimney may also have been inscribed.

The central entrance of the main house includes a three-pane transom, panelled jambs and an eight panelled door. A similar central door on the second floor once opened onto a two-story portico that embraced only the central bay of the house. According to Elizabeth Weimer, who owned the house from the 1920's until recently, her husband, James Weimer, removed the portico and built the present three-bay, one-story stone pillared porch.

The first and second floor windows all have 6/6 sash. On the southwest side, two windows light either floor level in each section. Two six-pane windows light the attic of the main section, and one such window lights the cellar. On the facade, a 3/6 window lights either extreme end of the cellar. The main floor levels of the northeast end are unfenestrated. Two four-pane windows appear in the attic. As the hill slopes away from this end, a 6/6 window and an entrance open into the cellar. The rear of the house includes windows in the three northernmost bays on the second floor, and in the two northernmost bays on the first floor. The windows are framed with narrow boards.

A porch, recently enclosed in stone, covers the northwest side of the kitchen.

The floor plan of the main section consists of a central stair hall with a parlor to either side. Four bedrooms are located on the second floor, two to either side of the stair hall.

The Logsdon Stone House is located in the area historically known as Arnold's Settlement, established by a group of Catholics who settled here in the late 18th century. The house was constructed in 1854 by Peter Martin for William Logsdon, who purchased the property in 1850.<sup>1</sup> The Logsdons were one of the original families in Arnold's Settlement.

The Logsdon Stone House is one of the largest, most finely constructed, and best preserved farmhouses in the George's Creek area. In plan, size, and finish details it resembles other mid-century houses in the region, such as the Morgan Brick Farmhouse (AL-V-A-048), and the Ridgley House (G-II-C-021), a sandstone house in neighboring Garrett County. The only other recorded local example of ashlar stone construction is the Robertson Stone House of circa 1845 (AL-V-B-071).

In addition to the house there are two significant secondary buildings and the site of an earlier two story log dwelling that was demolished after the stone house was completed.<sup>2</sup> The surviving barn is believed to pre-date the stone house.<sup>3</sup>

When the Weimers bought the farm in the 1920's, it had fallen into disrepair. The Weimers substantially repaired the farmhouse. Their son Bob, who now owns the farm, has maintained the buildings well.

Mrs. Weimer now lives in a frame farmhouse at the entrance to the Logsdon farm lane.

7.1 Description (Con't)

Much of the original interior woodwork is intact. The stair features a rounded handrail, square balusters, and a slender, slightly rounded newel. Plain flat boards, which may have once been trimmed with moldings, frame the windows. A flattened ogee molding surrounds the interior doorways. The mantels were removed in the 1920's, and Mrs. Weimer believes one may still be stored in the attic.

In the northeast parlor, a cupboard with panelled doors adjoins the fireplace in the east corner, and a closet fills the north corner.

The cellar has a fireplace at the northeast end, and possibly also at the southwest end.

Springhouse: The ashlar sandstone construction of the springhouse resembles that of the main house. This building is covered by a metal clad gable roof running southeast-northwest. The entrance is located in the southwest side, and single windows pierce each end wall. The spring originates to the northwest of the springhouse and is flanked by stone walls. A stone trough catches water at the southeast end of the building.

Barn: The timber frame bank barn is constructed of hewn members that are mortised, tenoned, and pegged together. A bay now appears to either side of a central aisle. The 19' long wall of each mow is constructed with no intermediate posts. A single central angle brace runs from sill to plate. Smaller up-braces reinforce each upper corner. A frame shed covering the west side appears to be either original, or an early addition.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Logsdon Stone House is located on the southwest side of the Bald Knob Road near Mt. Savage, Allegany County, near the intersection of Bald Knob Road and Hinkle Road.

The house basically consists of a two and one half story, five bay wide, rectangular shaped, main block. A two story wing abuts the main block on the northwest side and this wing forms an "L" shaped facade. The entire house is constructed of stone laid in regular ashlar bond and the wall treatments are plain. The entire facade is supported by an ashlar bond stone foundation and there is no apparent water table. The roof of the structure is gabled and is covered with tin materials while the eaves include close verges with fascia and boxed cornices. Windows in the building include pegged, double hung wooden sash frames with six-over-six lights. Shutters are placed on the front southeast side windows. Two single sash windows with six lights are placed in either of the gable ends of the main block. Also found in the southwest gable is a date and name stone. The main entrance is located on the front southeast side and features the original verticle paneled door with transom and transom light. The rear entrance is placed on the northeast side of the wing and leads to an enclosed frame porch. A three bay end porch is placed on the front southeast side and features a flat roof and entablature supported by square stone columns with balustrade. A door at the second story level opens to the flat roof of the porch and serves as a balcony. A straight flight of stairs leads to the front entrance level. Three original corbeled stone chimneys are found within the facade; two are located on the flush ends of the main block and one is on the flush end of the rear wing.

Several outbuildings are found on the property including a stone spring house and frame barn with ashlar foundation.

The house and farm are structurally very sound and retains most of its original appearance.

## STATEMENT OF SIGNIFICANCE

According to the date-stone in the southwest gable, the Logsdon Stone House was completely constructed by 1854. Placed in a rural setting, the house represents a very permanent and relatively fashionable residence for an agricultural family of the mid nineteenth century era. The house property was purchased in September of 1850, and construction of the house is assumed to have started soon after this date. <sup>1</sup> The house was built by Peter Martin for William Logsdon and required four years to construct. During the nineteenth century, soon after the French and Indian War, the Logiston family setteled in the vicinity of Cumberland and became members of the Roman Catholic Society. <sup>2</sup> The family names of Logiston and Logsdon are merely slight deviances in spelling and pronunciation and are of the same family stock. <sup>3</sup>

The house itself is one of a very few stone structures that are laid in regular ashlar bond in Allegany County, and thus far in the survey, it is the largest house of this type.

The house retains much of its original appearance and is an architectural reminder of a way of life in the agricultural areas of Allegany County.
