DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This dwelling is two stories tall and four bays wide on the southern-facing facade. Wall construction is frame covered with aluminum siding. The gabled roof is covered with asphalt shingles. Eaves consist of an aluminum cornice and soffit. The building rests on a low rubble stone foundation.

A wide hip roofed porch with square wooden posts on the facade is partially enclosed. Windows are 1/1 sashes. Some windows on the ground floor have been replaced with a modern picture window. The entrance is offset to the west on the facade and a modern door. A brick chimney with a corbeled cap is located on the interior of the building.

The house originally consisted of a small 16' by 20' three room dwelling. Additions have been added to the eastern and northern elevations.

STATEMENT OF SIGNIFICANCE

The Charles E. Winebrenner House was built during the second or third decade of the twentieth century by Charles E. Winebrenner. Mr. Winebrenner was a miner for the Union Mining Company whose duties consisted of opening mines. He also worked at times for the Mount Savage Refractories in the brickyards of the company in Mount Savage.

In the early twentieth century Mr. Winebrenner constructed the original portion of this dwelling, a small frame structure of three rooms which measured 16 feet by 20 feet. Additions have been added to both the eastern and northern elevations to give the house its present configuration. (Interview with Mr. Charles E. Winebrenner)

This dwelling was built one section at a time by Mr. Winebrenner, beginning with a modest three room structure. It is interesting as an example of early twentieth century vernacular housing.


