This site was inaccessible due to a locked gate across a private drive. The following description is excerpted from the Maryland Historical Trust survey files. This is a 1 1/2-story one-bay-square log house currently used as a barn. The logs are v-notched at the corner. The gable roof is covered with corrugated metal and has exposed rafter ends. The window sash has been removed and an additional door opening cut through the log wall.

Jacob Loar may have built the house in the mid 19th century. This deteriorated structure is recommended as not eligible for the National Register of Historic Places due to loss of integrity of design, materials, workmanship, and feeling.

Mid 19th Century

The Loar Log House is located on Barbers Hill Road near Loarville. This one and one-half story log house is one bay wide and one bay deep. Wall construction is of "V" notched logs with some mud chinking intact. The building has no apparent foundation.

The house was probably constructed by Jacob Loar around the mid-nineteenth century. In 1847 Loar acquired four contiguous tracts on the western flank of Dan's Mountain from Gustavus Beall. A county tax assessment of Loar's property made in 1867 refers to a "residence" and "household."

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This rectangular dwelling is currently used as a barn. The building is one and one-half stories tall and one bay wide on the northeastern--facing facade. Wall construction is of "V" notched logs with some mud chinking intact. The facade and northwestern elevation are covered with weatherboard siding. The building has no apparent foundation. The gabled roof is covered with corrugated metal. Eaves consist of exposed rafter ends.

The building has three window openings with no sashes intact. Entrance openings are located in the center of the facade and on the SE end of the SW elevation. An opening on the SW end of the SE elevation was apparently cut through the log wall at a recent date. A vertical board door on the southwestern entrance does not appear to be original. No chimneys or chimney passageways are apparent.

STATEMENT OF SIGNIFICANCE

Loar Log House was probably constructed around the mid-nineteenth century by Jacob Loar, the son of one of the founders of the village of Eckhart. (Stegmaier et al p. 84, and Land Records) In 1847 Loar acquired four contiguous tracts on the western flank of Dan's Mountain from Gustavus Beall, who kept the mineral rights to the property. The tracts were "Matthew's Addition," "Murdock's Addition," Polygram," and Military Lot #3683, the tract upon which the log house stands. (Liber 2, Folio 240, and Liber 515, Folio 54) A county tax assessment of Loar's property made in 1867 refers to a "residence" and "household" on unnamed tracts, presumably those listed above. In later years the farm was improved by a frame farmhouse and was referred to as the "George Henry Loar Farm." (Liber 186 Folio 155).


