DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Cutter House is located on the northern side of Morgan Road near Borden Shaft. The original portion of this building is a one story brick structure, one bay wide on the facade (southern elevation) and three bays deep on the southern elevation. Frame additions have obscured all but the eastern and southern walls of the original building. It rests on a high coursed ashlar stone foundation which has been obscured by a cinderblock porch base. A porch on the facade and southern elevation has a hipped roof supported by tapered square wooden posts. Windows are pegged 1/1 sash.
