Milestone No. ---(169), ^{a replica crownstone} in the town of Ellerslie, marks a point on Mason and Dixon's West Line close to 158 miles from the northeast corner of Maryland, the beginning of their 230.228-mile West Line. The monument is an embellished magnesian limestone post with a low pyramidal top, quarried and carved by the Beaver Dam Marble Co. in Cockeyville, MD, ^{is in excellent condition, firmly set, unaltered,} in 1902. It measures about 12 inches square, stands about 17 inches above ground; and, like the original crownstones, has vertical fluting with horizontally-fluted margins on all four sides, with the stylized shield of the Penn family coat of arms on the north side facing Pennsylvania and that of the Calvert family on the south side facing Maryland. In addition, on the east side is the year 1766 (when this area was preliminarily surveyed) and 1902 on the west side (when this site was established and monumented during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary). This crownstone is significant on the national and state levels primarily as one of the thematic group series of some 248 markers still visually defining the West Line, the boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. Locally, as one of 37 monuments marking the present Allegany/Fulton-Bedford-Somerset county boundary, it is also significant symbolically for its identifiable relationship to the colonial and Civil War heritage of these counties, and one of the few so conveniently accessible to the public. Of interest, also, is the fact that it was provided by the Historical Society of Pennsylvania in Philadelphia as an exchange for the ^{replacement} original crownstone, No. 115(119), ^{from Washington/Franklin counties} formally given the society in 1902.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Milestone No. ---(169) was a new crownstone^{replica} when set in 1902 at an additional site in Ellerslie on Mason and Dixon's West Line during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. It is an embellished Cockeysville marble post with a low pyramidal top; is in excellent condition, firmly set, unaltered; measures 12 inches square, stands about 17 inches above ground; and, like the original crownstones, has vertical fluting with horizontally-fluted margins on all four sides, with the stylized shield of the Penn family coat of arms on the north side facing Pennsylvania and that of the Calvert family on the south side facing Maryland. In addition, on the east side is the year 1766 (when this area was preliminarily surveyed) and 1902 on the west side (when this site was established and monumented by the Resurvey).

The area here is the center of the small town of Ellerslie, MD, in the low-lying Wills Creek valley between Wills Mountain to the east and Little Allegheny Mountain to the west. The site is within Election District 20 of Allegany County, MD, and Londonderry Township of Bedford County, PA; about 440 feet west of the preceding monument No. ---(168); west of Wills Creek, the B&O and Penn Central railroads; at a point about 20 feet west of MD 35/PA 96 at the Line, in the front lawn of Redeemers United Church of Christ, about 3 feet above street level. It can be easily seen from the road, all seasons, and seems to be locally protected.

The monument, as with Milestone No. 50 (53) the crownstone replica in Baltimore County, was quarried and carved in Cockeysville, MD, by the Beaver Dam Marble Co. ^{in 1902} and is of a white, fine-grained marble called saccharoidal dolomite or magnesian limestone. Both replicas were provided in a formal exchange for original crownstones given at that time to the Maryland Historical Society (No. 50) and the Historical Society of Pennsylvania in Philadelphia (No. 115). This Ellerslie replica has chips at the top corners (particularly the northwest and southeast), but the top planes with fluting and apex are otherwise intact, as are the shields, fluting and numbers.

STATEMENT OF SIGNIFICANCE

Milestone No. ---(169) is significant on the national and state levels primarily as one of the some 248 markers of the thematic group series still visually defining Mason and Dixon's West Line, the 230.228-mile boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. This part of the Line was preliminarily surveyed in 1766, marked at irregular intervals with cairns and additional wood posts the following year, and the present site on the Line established and monumented in 1902 with a new Cockeysville marble crownstone replica during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. Locally, as one of 37 markers along the present Allegany/Fulton-Bedford-Somerset county boundary, No. ---(169) is also significant for its identifiable relationship to the colonial and Civil War heritage of these counties, and one of the few so conveniently accessible.


