

## ABSTRACT

Milestone No. ---(168) at the <sup>eastern</sup> edge of the small settlement of State Line, on the western foothills of Wills Mountain, is about 4500 feet west of the preceding monument/mound, No. ---(167) on the ridge of Wills Mountain (close to 158 miles west of the northeast corner of Maryland, the beginning of Mason and Dixon's <sup>230,228-mile</sup> West Line). It is a very plain dressed Cockeysville marble monument with a low pyramidal top, of the same design and source as 65 other new monuments set during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary west of Sideling Hill. It is in excellent condition, unaltered, firmly set (though slightly out of plumb); measures about 10 inches square by about 22 inches high above ground (with some of its rough-cut base now exposed); and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1766 on the east side (when this area was preliminarily surveyed), and 1902 on the west side (when this site was first established and monumented). No. ---(168) is significant on the national and state levels primarily as one of the thematic group series of some 248 markers still visually defining the West Line, the boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. Locally, as one of 37 monuments marking the present Allegany/Fulton-Bedford-Somerset county boundary, it is also significant symbolically for its identifiable relationship to the colonial and Civil War heritage of these counties.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

Milestone No. ---(168) was a new monument when set in 1902 at an additional site on Mason and Dixon's West Line during the course of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. It is a <sup>dressed</sup> Cockeysville marble post with a low pyramidal top; is in excellent condition, firmly set, unaltered; measures 10 inches square by about 22 inches above ground; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, ~~and the year~~ 1766 on the east side (the year this area was preliminarily surveyed), and 1902/<sup>on the west side</sup> (when this new site was first monumented).

The area here is the sparsely settled eastern fringe of the town of Ellerslie called State Line, <sup>and</sup> the western/<sup>wooded</sup> foothills of Wills Mountain. The site is within Election District 20 of Allegany County, MD, and Londonderry Township of Bedford County, PA; about 4500 feet west of the preceding monument/mound, No. ---(167) on the ridge of Wills Mountain; at a point about 2900 feet east of Wills Creek, <sup>an unmarked road paralleling it on the east</sup> and the western Maryland Railroad at the line and about 1800 feet southeast of the Charles Wisler house (in back of the pumping station); about 1000 feet southwest of the new gas pipeline, at the south end of a wooded ridge, in an east-west old barbed wire fence. It cannot be seen from any road or the pipeline, but is easily found when closeby, and seems protected <sup>and the Wislers</sup> by the fencing/

The monument, identical to 65 other monuments of 1902 west of Sideling Hill along the Maryland-Pennsylvania boundary, was quarried and carved in Cockeysville, MD, of a white, fine-grained marble called saccharoidal dolomite or magnesian limestone; was originally cut about 10 inches square by about 4½ feet long, intended for setting about 1½ feet above ground, with the remaining <sup>rough-cut base of about</sup> 3 feet for setting firmly into the ground. The letters and numbers are blocky, V-sunk without serifs, and are horizontally aligned as a band around the stone near the top. This monument is in near-perfect condition, though slightly out of plumb <sup>about 6 inches of</sup> and with <sup>the base</sup> showing above ground.

STATEMENT OF SIGNIFICANCE

Milestone No. ---(168) is significant on the national and state levels primarily as one of the some 248 markers of the thematic group series still visually defining Mason and Dixon's West Line, the 230.228-mile boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. This part of the Line was preliminarily surveyed in 1766, marked at irregular intervals with cairns and additional wood posts the following year, and the present site on the Line established and monumented in 1902 with a new Cockeysville marble marker during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. Locally, as one of 37 markers along the present Allegany/Fulton-Bedford-Somerset county boundary, No. ---(168) is also significant for its identifiable relationship to the colonial and Civil War heritage of these counties.

MARYLAND-PENNSYLVANIA-WEST VIRGINIA


