

JENKINS LOG FARM HOUSE

.3 mile south of Cabin Run Road
ca. 1820

The Jenkins Log Farm House consists of a one and a half story, three bay wide, rectangular shaped structure with two one story shed roof additions. The house is typical of the early farm settlements found in Allegany County and was probably erected circa 1820. The farm is constructed of logs; logs being the primary construction material during the early settlement period of the County. The farm also includes a large log barn near the house with logs up to forty five feet long. The construction features "V" notching with mortice and tennon pins.

The Log Farmhouse is situated 0.3 miles south of Cabin Run Road, north of the town of Midland. The farm includes a true 1½ story log house and a double pen log barn.

The two-bay farmhouse faces south. The stone cellar is exposed on this side. A pent roof extending from the main gable roof covers the facade. Late 19th century frame additions cover the west and north sides.

The building appears to have once included a chimney at the west end. A brick stove-flue chimney now heats the center of the rear. The facade features a central entrance with a 6/6 sash window to the west. A single window lights the east end. Plain flat boards frame the openings. Weatherboards cover the building. Board-and-batten siding covers the facade. Asphalt shingles sheath the roof. The log corners are joined with V-notching.

The building features a hall and parlor floor plan. A beaded board wall divides the two rooms. Either addition consists of a single room.

A boxed stair turns in the northwest corner of the original section. The loft is also divided into two rooms.

The west addition is a frame construction. The multiple-layer wall construction of the north addition comprises studs, vertical boards, and horizontal boards.

The log barn is covered by a gable roof running north-south. The 50' x 20' structure includes two 15' x 20' log pens with a central aisle.

The Log Farmhouse is a typical example of one of the early farm settlements found in Allegany County, and was probably built circa 1830. The farm is typical in that both the house and barn were erected from logs; logs being the primary construction material during the early settlement period of the county.

The farms during the early settlement days usually served as subsistence types of agricultural sites and it was not until later in the 19th century that larger commercial farms began in Allegany County. Of particular interest is the large log barn which stands several hundred feet south west of the log house. The barn is constructed of logs up to forty five feet long and are jointed with "V" notching and mortice-and-tennon pins.

The farm site itself is very similar in size and construction to the Crow Farm, AL-V-A-047 which is located approximately one mile north of the Jenkins farm and both feature large log barns. The farmhouse is in deteriorated condition and is now abandoned.

The Log House at Cabin Run is similar in plan, size and materials to the house at New Hope Farm (AL-V-A-255) and the Edward Barnard Homestead (G-IV-C-043). The Cabin Run House measures 24'-3" by 18'-2", while the Barnard House measures 22'-5" by 18'-5". All three hall and parlor log dwellings originally were heated by an exterior stone chimney at gable end of the hall. Each building also features an original pent roof extending to protect the facade.

The double-pen log barn resembles those at the Graham Mansion (AL-V-A-014) and the Thomas Wright Farm (AL-VI-B-036). The oversailing log corners are a significant early feature, seen also at the Barnard House. The Cabin Run barn is especially well preserved.

The house is significant for its early log construction as well as for the construction of the north addition. This structure's wall utilizes five layers of small studs and horizontal and vertical planks sandwiched together. This construction seems to be either transitional between stud-frame and plank construction, or a deliberate cross of the two types.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Log Farm House is located .3 miles south of Cabin Run Road and faces due south.

A covering of vertical boards and plain battens now sheathes the thick log walls that originally composed the exterior of this farm house. The structure was built upon a high stone foundation to accommodate the hill there that slopes from west to east. Two one story shed roofed additions have been added to the original one and a half story rectangular log house. They consist of one on the west side covered with vertical boards and plain battens, coupled with one abutting the north side that is constructed of weatherboarding. The doors and windows of the structure have been completely removed. Replaced asphalt shingling covers the gabled roof. A three bay front porch with a shed hood now lacks the mechanical support of its original columns. Three chimneys, two brick and one cement block, have flush end and interior locations in the house.

The rectangular log barn built on the property now stands improved and enlarged with the addition of two side frame wings. "V" notching was used to secure the corners of the early barn, which has a tin covered gabled roof.

The log Farm House is in deteriorated condition, after having been left to decay. The barn is in fair to poor condition.






