The Llewellyn Log House was constructed in two parts; the original log portion and a later frame addition. The original log part being a one and a half story, two bay wide structure, while the frame section is a two story, one bay wide portion. The original portion of the house was built circa 1856 by Phillip and John Llewellyn as a subsistence type of farm. The log cabin was a popular form of housing in Allegany County in the early settlement period in that they were inexpensive and easy to construct and were very sturdy.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Llewellyn Log House is located on the north side of Buskirk Hollow Road near Gillmore, Allegany County near the top of Dan's Mountain.

The Llewellyn house was constructed in two parts. The original portion being a one and a half story, two bay wide log structure, while the northern side or addition features a two story one bay wide frame section. The entire facade has been covered by novelty siding and it is supported by a high stone foundation with a plain water table. A one story shed roof wing abuts the frame structure on the rear eastern side, while a gabled one story springhouse adjoins the wing. The roof of the structure is gabled and covered with replaced asphalt materials. The eaves exhibit boxed cornices and a narrow soffit on the main block and rafter ends on the springhouse. One shed roof dormer is placed off the front western side of the original log portion. Windows in the facade include double hung wooden sash frames with two over two and six over six lights and pediments as well as single sash frames with six lights. The main entrance is located on the front western side and exhibits the original paneled door with transom and side lights. The entrance is covered with a three bay end porch with shed roof. The roof is supported by square columns with cushion capitals and banistered stone pedestals. A stone stairway leads to the entrance level of the house and the steps have been capped with cement. Two original chimneys are found on the structure, one being a brick chimney located on the outside end of the rear wing and the other being a corbeled stone chimney located to the interior of the frame facade.

The house is structurally sound; however, it has been somewhat altered by the novelty siding and other wing additions.

STATEMENT OF SIGNIFICANCE

The Llewellyn log house originally was a subsistence type of farm which was probably built circa 1856 by Phillip and John Llewellyn. The Llewellyns were patented the land called "Fairview" on January 17, 1856 and it is believed that the log portion of the house was built soon after this date. The house and plot of land has remained within the Llewellyn family all through its history and the present owner, Ablert M. Llewellyn has constructed a new residence to the east of the old site.

The log cabin remained a popular form of housing in Allegany County throughout the early settlement era and even into the present century. They were inexpensive to build, easy to construct and extremely sturdy. In the early settlement era of this county, the logs used were the most readily available construction materials and in many cases the poorer settlers took advantage of these items. As found with many of the log structures in Allegany County, this house has been covered with siding. However, the house remains an architectural reminder of a way of life once found in Allegany County.


