## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Casper Hadley complex includes an early 20th century balloon frame house, a frame bank barn also dating from the early 20th century and frame sheds and outbuildings. They are located on a gravel road which passes through the Park.

The house is vacant and slated for demolition. It is a two story, three bay structure sheathed with grey composition siding. Windows have three over one light sashes. The entrance is located in the central bay of the front elevation and has two light transom above a four panel door. A hipped roof porch once extended across the entire front elevation.

The roof is sheathed with asphalt shingles and extends beyond the end walls of the house. A centrally located brick flue protrudes from the roof.

A small ell extends to the rear of the buildings. The house faces northeast.

On the opposite side of the road from the house is a mortise and tenoned timber frame bank barn with vertical siding. Its dimensions are approximately 30' x 40' and its foundations are of finely coursed native stones. The roof is sheathed with asphalt shingles.

The frame sheds and outbuildings all appear to date from the early 20th century.

STATEMENT OF SIGNIFICANCE

The Casper Hadley house is a c. 1900 typical frame dwelling in poor condition, exhibiting no architectural or historical significance.

The barn, also dating from the turn of the century period, exhibits typical characteristics of barn construction and good workmanship. The sleeper, framing members and major elements of the roofing system are hand hewn. The barn exhibits traditional methods of construction no longer practised by modern builders. It remains in relatively good condition, as of August, 1978, needing only a new roof for stabilization.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Miller Farm House is located on Dan's Mountain State Park Road in Dan's Mountain State Park, Lonaconing, Allegany County.

The Miller Farm House consists of two sections: the original log portion, now located at the rear of the building and a later 19th century portion which consists of a two story, three bay wide frame block. The entire structure has been covered with insul brick and both sections rest on a low stone foundation. The roof of the 19th century section is gabled with a boxed cornice and returns while the roof of the log section is steeply gabled with a deep over-hang on the east side providing a small two bay porch. All windows in the house have been replaced and consist of double hung wooden sash frame with a combination of one over one and three over one lights. The main entrance is located on the northeast facade and consists of a vertically paneled door with original hardware. Two original brick chimneys are located in the interior of both the log and the frame sections.

Located to the east of the house is a large barn with a cut stone foundation. The barn was constructed using the traditional frame of posts and beams mortised together.

Both the house and the barn are in deteriorated condition and are no longer occupied.

STATEMENT OF SIGNIFICANCE

The original log portion of what is now known as the Miller Farm House was probably constructed ca. 1840 by John Hoyer. In a survey record for November 15, 1838, Hoyer is called the "first discoverer" of military lots numbers 3778, 3779 and 3780. The lots were resurveyed for Hoyer in 1838 and given the name "Coromandel." The land on which the Miller Farm House sits was known as "Coromandel" as late as 1945. The farm received its name from the Miller family who first purchased the property from the New Central Coal Company.<sup>1</sup>

Architecturally, the log portion of the house is typical of log architecture in the first half of the 19th century. That is, it consists of a one room log cabin with a loft. The roof is steeply gabled to provide drainage and the building rests on a stone foundation.




