DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Meyer's Log House is located at 37 E. Main Street, Lonaconing, Allegany County.

The Meyer's House is a two story, four bay wide, cross shaped building of frame and log construction that has since been covered with aluminum siding. The entire structure rests on a low stone foundation. The roof is gabled with a boxed cornice and returns and has been covered with replaced asphalt shingles. Windows in the structure have been replaced and feature double hung, wooden sash frames with one over one lights with plain trim and cornices. A large, single story bay window is located on the southeast facade. Two entrances are also located on the main facade and feature replaced paneled doors. One of the doors is of special interest in that it has a large etched glass panel in it, one of two found in Lonaconing (See Historic Inventory Survey form # AL-VI-B-085). Both entrances are covered by a shed-roofed wrap around porch supported by frame and brick supports. Several small gable-roofed additions are located at the rear of the structure. A single, corbeled brick chimney is located on the outside gable end.

STATEMENT OF SIGNIFICANCE

The Meyer's House was originally a two room log structure¹ which was probably constructed by the Georges Creek Coal and Iron Company during the first half of the 19th century. The company exercised almost feudal control over the town of Lonaconing until the 1850's. During that period, they not only built a large number of "company houses" but also bought up most of the existing houses in the town.² Given its proximity to the Lonaconing furnace (Historic Sites Inventory Form #AL-VI-B-004), the Meyer's Log House was probably constructed to house an iron worker for the George's Creek Coal and Iron Company. The house was owned by the company until 1890.³

The Meyer's House has been altered significantly since its original construction and the log portions are no longer visible.




