The F. W. Weber Company was probably constructed after the Lonaconing fire of 1881. The building is of special interest in that its facade has been preserved in its original state complete with a large wooden sign, shop windows with bead and reel moulding and original brass hardware on the main entrance. The interior is in near original condition as well and consists of a single room with varnished oak and glass cases and a pressed tin ceilings.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The F. W. Weber Company is located on the east side of Main Street, Lonaconing, Allegany County.

The F. W. Weber Company building is a two story, three bay wide frame structure that has been covered with novelty siding. The entire structure rests on a low stone foundation. The shed roof is supported by brackets and a frieze on the northwest facade. Windows on the second floor are double hung wooden sash frames with one over one lights. Each window is topped by a cornice and two brackets. A large wooden sign with the words "F. W. Weber Company, 5 & 10 Store" emblazoned on it is located just below the second story windows providing the wall for a small balcony. Windows on the first floor are large show windows with bead-and-reel mouldings. The main entrance is located on the northwest facade between the two show windows. It consists of two double doors with glass panels and an intricately carved brass handle. A single transom is located above the doors.

The interior of the building remains in near original condition. It consists of a single, narrow room with numerous varnished wood and glass display cases and a pressed tin ceiling.

STATEMENT OF SIGNIFICANCE

On September 7, 1881 the Town of Lonaconing suffered its worst fire in decades. The blaze started in a stable and in three hours fifty three buildings had burnt to the ground. As a result of the fire, the majority of the Town was rebuilt during the last decade of the 19th century.¹

It is not known how much the F. W. Weber Company may have suffered in the blaze. In the early part of the 20th century the Weber building was part of the Miller furniture Company. The original Miller building has since been divided in half, one half is used for the Weber Company and the other for Pat's Furniture Company. The building is still owned by the Miller family.




