2 Union Street, Lonaconing
ca. 1882

The Brady Hotel was first constructed in approximately 1870 by James T. Brady. However, the original hotel burned in the Lonaconing fire of 1881 and the present brick building was constructed. Both the interior and the exterior of the hotel remain essentially unchanged.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Brady Hotel is located at 2 Union Street in Loanconing, Alle-gany County.

The Brady Hotel is a three story, seven bay wide rectangular struc-ture. The building is constructed brick laid in American Common Bond with a six to one variation. It rests on a low brick foundation and has a flat roof with a stepped parapet on the western facade. The eastern facade has an entablature supported by brackets. Windows in the structure are double hung, wooden sash frames with a combination of four over four, two over two and one over one lights. The majority of windows have rock-faced stone lintels. The main entrance is located on the north side and features a replaced door with both side lights and a transom light. The door opens into an enclosed hipped roof porch supported by Roman Doric columns. The unenclosed portion of the porch extends the length of the building.

STATEMENT OF SIGNIFICANCE

The original Brady Hotel was a frame structure constructed in the 1870's by Mr. James T. Brady.¹ Unfortunately this building was badly burned in the Lonaconing fire of 1881 and as a result, the present structure was constructed.² The Brady family sold the hotel in 1939.

Although the facade of the building has been altered somewhat, the interior and more especially the bar, located on the ground floor of the building, remains essentially unchanged. Drinks are still served on a bar of varnished wood and bottles are kept in leaded glass cabinets while the bartender is reflected in a large mirror with an elaborately carved frame.

Sanborn Fire Insurance Maps






