

Log Farmhouse, Dan's Mountain Road
AL-V1-B-169
Dan's Mountain Road, Lonaconing

This log house is located on the western flank of Dan's Mountain near the mining town of Lonaconing. Physical evidence indicated that it most likely was a farmhouse built at the time of the Civil War when the George's Creek Coal and Iron Company, which dominated the Lonaconing area, "relinquished its grip" on the land. The population of Lonaconing in 1878 included thirty-one farmers, many of whom were probably miners who had saved enough of their earnings to purchase farmland.

The house is typical, although somewhat larger than average, of log houses in Allegany County built during the mid-nineteenth century. It is two stories tall and three bays wide, resting on a substantial stone foundation. Logs are joined with the locally popular "V" notching. A barn near the farmhouse has been removed.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building is a two story, three bays wide rectangular structure with logs joined with "V" notching and covered with weatherboard siding. It rests on a high foundation of random rubble with a plain watertable. The gable flank roof is of ribbed tin covered with asphalt shingles. Eaves consist of a cornice and soffit with a frieze and returns on the gable ends. A replaced cinderblock chimney is located outside end.

Entrances in center of the southeastern and northwestern facades include four paneled replaced doors. Original windows are pegged six over six lights, others are replaced two over two lights. A shed roofed porch on the northwest has square wooden posts.

A U.S.G.S. map of 1950 shows that a barn just northwest of the log house which has been removed.

STATEMENT OF SIGNIFICANCE

This log house is located on the western flank of Dan's Mountain near the mining town of Lonaconing. Because the property was owned for many years by different coal companies it is difficult to trace the title to obtain information necessary to determine its previous ownership or the age of the farmhouse. Physical evidence indicates that it most likely was a farmhouse built at the time of the Civil War when the George's Creek Coal and Iron Company which dominated the Lonaconing area "relinquished its grip" on the land. (1)

The house is typical, although somewhat larger than average, of log houses in Allegany County during the mid-nineteenth century. It has a three bays wide facade, rests on a substantial stone foundation, and is constructed with the locally popular "V" notched logs.

"Lonaconing had thirty-one farmers in 1878" and many of these were undoubtedly miners who saved enough of their earnings to purchase farmland. (2) Many area farms were owned by coal companies which rented their properties to farmers. (3) Regardless of the farm's origins it was one of many in the area whose produce was essential in supporting the large industrial population of the mining region.


