The Nicol Board and Batten House is located on Charlestown Road in Charlestown. The dwelling was built between 1881 and 1896 by John Wright who was a Welsh miner. The building was sold to Alexander Nicol in 1897 through an Equity Case in which testimony indicated that there was a dwelling on the lot. At one time a saloon was operated in the house. The two story three bay wide house was drastically altered with a large frame addition and a replaced roof. The entire structure is covered with board and batten.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building originally consisted of a one and one-half story, three bays wide frame structure with board and plain batten. A large frame addition, with board and batten siding and resting on wooden posts was added onto the north of the original. A second addition is a two story, one bay wide frame structure with board and batten resting on a high foundation with random rubble. The original building rests on a high stone foundation of coursed rock-faced ashlar with a plain water table. The gable flank roof, which has been enlarged to cover the original and the first addition is covered with tar paper. Eaves consist of a cornice and frieze on the flanks and are close pent with a frieze on the gable ends. Two brick chimneys on the additions have corbeled caps.

The main entrance in the center of the southern facade includes a four paneled door with original hardware. Windows throughout the structure are pegged six over six light sashes with wooden lugsills. A porch on the south has a hipped roof supported by replaced wooden posts. A porch on the east has a shed roof.

STATEMENT OF SIGNIFICANCE

The Nicol Board and Batten House is located on Charlestown Road in Charlestown. Charlestown is a small village located adjacent to Lonaconing.

The dwelling was built between 1881 and 1896 by John Wright who was a Welsh miner. (1) In 1896 it was inhabited by Charles Nicol. (2) The building was sold to Alexander Nicol in 1897 through an Equity Case in which testimony indicated that there was a dwelling on the lot. (3) James Nicol, a coal miner from Scotland, bought the property in 1904. (4) At one time a saloon was operated in the house. (5) During the late 19th and early 20th centuries there were as many as forty saloons in Lonaconing. A great many of these were "family saloons" that were maintained for the purpose of supplementing the family income. (6)

The two story three bay wide house was drastically altered with a large frame addition and a replaced roof. Material for the addition was reportedly taken from a neighboring dwelling. The entire structure is covered with board and batten.
