DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated in a hilly, semi-wooded area on Rt. 55 in the town of Miller. The house faces northwest. It is a two story, three bay by one bay structure with a single bay deep ell. A wooden porch, supported by square posts with victorian trim and brackets and jig-sawn balustrades, covers the facade bays. The house is entered from the central facade entrance.

The house has a central brick chimney. One over one sash windows, with drip cap molding, light the house. The house rests on a stone foundation. Vinyl siding covers the house with asphalt shingles on the roof.
