The Boal House

The Boal House is located on Railroad Street in Barton, Maryland. John Boal bought the lot in which this house is located from Andrew B. Shaw in 1871. Mister Boal built two single, two story frame houses on the property of which only one remains. They were built in the last quarter of the nineteenth century. This rectangular building is two stories tall and has an unusual width of seven bays. The wall construction is frame with board and batten covered with insul siding. Two original brick chimneys remain, one is corbeled, and are located on the interior.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Boal House is located on Railroad Street in Barton, Maryland.

This rectangular building is two stories tall and seven bays wide. The wall construction is frame with board and batten, covered with insul siding. It rests on a high stone foundation of random rubble and on log posts on the southwest, with no apparent water table. The gable flank roof is covered with asphalt shingles, the snowboards, have been removed. Eaves consist of boxed cornice, soffit, frieze, and returns. Two original brick chimneys, one corbeled, are located on the interior.

The main entrance in the center of the southeastern facade includes a one light transom and a replaced nine light door. Windows are three over one light sash with wooden slip sills. Some original six over six light windows remain. A full length shed roofed porch on the southeast has been enclosed on both ends. A shed roofed porch is on the southwest.

STATEMENT OF SIGNIFICANCE

This board and batten house is located in the village of Barton, Barton was laid out in 1853 by William Shaw Jr. The land on which it was located was part of his Father's 1,200 acre estate. Reverend William Shaw was originally from Barton-on-Humber, England, the town for which Barton was named.

Andrew Bruce Shaw sold the lot on which this house is located to John Boal in 1871. (2) John Boal built two single, two story frame houses on the property of which only one remains. (3) They were built in the last quarter of the nineteenth century and were rented out by Mister Boals. (4) John Boal died in 1899, and his heirs sold the property at a public auction. (5) The house is currently owned by John and Elma Myers.(6)






