The Georges Creek Pratt Truss Bridge was fabricated in 1900 by the Toledo Bridge Co. This single-span Pratt half-hip pony truss bridge carries Morrison Road over Georges Creek. It is a steel, riveted connected bridge with a metal mesh deck, and rests on concrete abutments.


