The Harmon Broadwater house is a single story, three bay by two bay gable roof structure with a shed dormer on the facade and rear elevations of the roof.

The house rests on a stone foundation. German siding framed with cornerboards covers the house.

A frame springhouse is located directly to the rear of the house and a coal house behind that. A chicken house and garage are also located on the property.

The present chicken house originated as a dwelling. It was built by Jake Fazenbaker circa 1880-1890 and was later lived in by John Smith.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated in a hilly, wooded area on Mill Run Rd. approximately 1/2 mile west of Georges Creek Rd. The house faces north. It is a single story, three bay by two bay gable roof structure with a shed dormer on the facade and rear elevations of the roof. A wooden porch supported by turned posts covers the facade bays. A similar porch is located along the east half of the rear, south, elevations. The house is entered from the central facade entrance with transom or from an entrance at the rear porch.

The house has a central brick chimney. Three over one sash windows, with drip moldings, light the house. Three pane windows are located in the dormers. Double windows are located on the facade. The house rests on a stone foundation, German siding framed with cornerboards covers the house with tarpaper on the roof.

A frame spring house is located directly to the rear of the house and a coal house behind that. A chicken house and garage are also located on the property.

The chicken house, once a dwelling, is a one-story, three bay by one bay gable-roofed structure. The board and batten building may be constructed of vertical planks.

STATEMENT OF SIGNIFICANCE

This house is a common western Maryland type. Houses of this rectangular configuration single story with shed dormers were built in Allegany County in the early twentieth century. The house was built in 1915. The present owner, Mr. Harmon J. Broadwater bought the house in 1927 after renting it for one year.

The present chicken house originated as a dwelling. It was built by Jake Fazenbaker circa 1880-1890 and was later lived in by John Smith.


