DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Luke Annex House is located on Hanover Street in Luke.

The building is an irregularly shaped two and one-half story, four bays wide frame structure. Wall construction is frame with narrow clapboards and angular imbricated shingles. The shingles are located in a band around the building at the second story which is flanged outward. The high stone foundation is of random rubble with a plain water table. The gable front roof is covered with asphalt shingles. Eaves consist of a boxed cornice, soffit, bed mould, frieze, and decoratively sawed brackets. One gable roofed dormer is located on the southwest. A tall brick chimney on the interior has an intricately corbeled cap and a single chimney pot. Two two and one-half story wings extend perpendicularly from the main rectangular block on the southwest and northeast. A five sided bay window is on the southern corner of the building. ( A frame addition on the northwest which rests on a cement foundation is possibly an enclosed porch).

The pedimented main entrance, offset on the southeastern facade includes a one light transom and a three light, three panel door with replaced hardware. Pedimented windows are nailed one over one light sashes mostly in pairs. A hip roofed wraparound veranda on the southeast has an offset gable above the entrance, ten chamfered square wooden posts, and turned balusters.


