DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

This small stone and frame house is located at the end of a long dirt road east of Underwood Road.

It appears on the 1860 and 1878 county maps, owned by Dr. M. M. Duvall and W. A. Carr respectively. Carr owned another house a little to the south and 350 acres of land.

The Kimm residence has two sections, both two stories high. One part (facing east) has a gambrel roof, and a massive center chimney. The south end wall is laid in rough fieldstone up to the level of the second floor. There is a small window in the frame gable. The other part of the house faces south. It is three bays long and has an A-roof. Its east end is connected to the gambrel-roofed section by a low hyphen. There is a large, exterior, brick chimney at the west end of the A-roofed section.

The structure appears to be in good condition. The siding is asbestos shingle.
